Sample note for Item 1 Sexual Abuse: (These are sample notes that could be used to capture human trafficking dynamics, if they exist)

Item rated a 2: Youth reported that her mother's "boyfriend" touched her breasts after he provided her mother with drugs. She was extremely upset as it seemed that her mother actually allowed this to happen.

Item rated a 3: Youth indicates that the person she stays with when she is on run would often times leave her alone with males in order to get the money needed to keep the place, they stay in. She stated that she loves him and will do whatever is necessary, including sex with strangers. She has been doing this over the past 60 days. She hopes to be done with this by the time she turns seventeen.

36. LEGAL – This item describes the child's (not the family's) involvement with the legal system. This could include involvement in the Juvenile or Adult Justice Systems.

Sample note for Item 36 Legal: (These are sample notes that could be used to capture human trafficking dynamics, if they exist)

Item rated a 2: Youth is on probation for petty theft and curfew violations. The youth reports that he does what he needs to do to survive when on run. Sometimes he steals food and items he can sell. Other times, he must do worse stuff, but will not say what that is.

Item rated a 3: Youth has a court date coming up this month regarding assault charges. She stated that she was angry when the man she had sexual relations with refused to pay her. She needs to make a certain amount of money to make her 'boyfriend" happy. Looking at her other legal offenses (loitering and curfew violations) she may be a victim of human trafficking.

40. SEXUAL DEVELOPMENT – This item looks at broad issues of sexual development, including sexual behavior, sexual identity, sexual concerns, and the reactions of significant others to any of these factors.

Item rated a 3: Youth is transgender girl who has frequent sexual contact with men she meets at the park. She has accepted money as gifts from men. She has been physically assaulted three times in the last two months by cars full of men that picked her up in the early hours of the night. She denied she was raped.

66. RUNAWAY - In general, to classify as a runaway or elopement, the child is gone overnight or extremely late into the night. Impulsive behavior that represents an immediate threat to personal safety would also be rated here.

Item rated a 3: Youth is frequently on run. She only returns to the treatment facility to "chill" for a few days and then is gone. She often comes back wearing more expensive clothing than what she left with. Sometimes, she convinces other female youth to run away with her and meet up with her and her boyfriend.

71. SEXUALLY REACTIVE BEHAVIORS - Sexually reactive behavior includes both age-inappropriate sexualized behaviors that may place a child at risk for victimization or risky sexual practices.

She stated that her mother did not believe her when she asked for help. She stated she knew then that she could only count on herself. Overtime, she has just come to accept that men only want her for her body. She uses their weakness against them to get what she wants. She feels she can get any male to give her anything she wants. She even stated that she has someone that will take care of it, if any man hurts her.

90. INTIMATE RELATIONSHIPS - This item is used to rate the individual's current status in terms of romantic/intimate relationships. This item supplements information from the Ansell-Casey assessment.

She will not share what he is asking her to do, but she did say that she is confused about why a boyfriend would ask her to do those things with other people.

Item rated a 3: The youth has known her boyfriend for about 2 months. He is nineteen, four years older than her. She has run away from the placement several times to be with him and stays with him while she is gone. She has no source of income and is completely dependent on him for everything when gone. She came back recently with bruises and marks on her. She stated that her boyfriend was disappointed in her and it was her fault he got so mad. She said he was only a little rough with her because he cares so much about her. She does not understand why he wants her to have sex with other men.

93. VICTIMIZATION - This item is used to examine a history and level of current risk for victimization.

Sample note for Item 93 VICTIMIZATION:

Item rated a 2: 9 months ago, youth was sexually assaulted by a former boyfriend but declined to press charges out of fear of retaliation. Youth blames self and continues to have online contact with perpetrator and excuse his abusive behavior. He is worried that getting back together with his boyfriend might mean a return to his previous way of making money for him.

Item rated a 3: Youth was raped a party while intoxicated 3 weeks ago. Youth has a history of risky sexual behaviors and substance use. Youth has befriended an older male (over 18) who buys her presents and controls her contact with family. He frequently hosts parties and expects her to be there every time. Youth frequently stays out all night and does not tell her family where she goes or whom she is with.
