2. Studies are organized by the country where the fieldwork took place, and by the first author’s last name within each country group
3. In general, a publication contained a single “study” (or experiment) in one particular country.
 - a. For special cases, see points #4-7 below
4. If the same publication included separate studies that occurred in multiple countries, then the publication appears in multiple country groups and are distinguished by a letter that appears after the year.
 - a. Bovenkerk1979 appears twice: once as Bovenkerk1979a for Netherlands and Bovenkerk1979b for France.
 - b. Akintola2010 appears twice: Akintola2010a for Sweden and Akintola2010b for Canada
5. Sometimes, a single publication contained multiple studies in the same country: e.g., one experiment is a correspondence test and the other is an in-person audit study
 - a. Henry1985 contained three studies in France, which are indicated as follows in the Stata file: Henry1985a, Henry1985b, Henry1985c
 - b. Pierné2013 contained two studies in France, which are indicated in the Stata file as Pierné2013a and Pierné2013b
 - c. Goldberg1996 contained two studies in Germany, which are indicated in the Stata file as Goldberg1996a and Goldberg1996b
 - d. Brown1985 contained two studies in Great Britain, which are indicated in the Stata file as Brown1985a and Brown1985b
 - e. McIntosh1974 contained two studies in Great Britain, which are indicated in the Stata file as McIntosh1974a and McIntosh1974b
 - f. Bovenkerk1995 contained three studies in the Netherlands, which are indicated as follows in the Stata file: Bovenkerk1995a, Bovenkerk1995b, Bovenkerk1995c
 - g. Birkelund2014 contained two studies in Norway, which are indicated in the Stata file as Birkelund2014a and Birkelund2014b
 - h. Decker2014* contained two studies in the U.S., which are indicated in the Stata file as Decker2014a and Decker2014b
 - i. *Should be corrected to Decker2015 in the Stata file
6. In one case, the letters are also used to indicate that there are two separate publications in the same year with the same first author:
 - a. Andriessen2012a and Andriessen2012ba. Again, these are separate publications. They have similar but different sets of authors.¹
7. In one case, there was a secondary publication that provided supplementary data for “main studies” in other (primary) publications

¹ Andriessen2012a is an English publication authored by Andriessen, Nievers, Dagevos, and Faulk. Andriessen2012ba is a Dutch publication authored by Andriessen, Nievers, and Ross.

- a. Heckman1993 includes paired data from two Urban Institute Studies that were not reported in the original studies (Cross1990, Turner1991); the data from Heckman1993 were used to supplement the data in Cross1990 and Turner1991, but it did not contain a new experimental study per se
